New members should first learn the rules in Section A. To prepare for their first ratings, new members should then also become familiar with Section B and the relevant Sections C through E and G through H. Sections F and I through N cover advanced ratings.

A. General Rules

These general rules apply to all members.

A.1 Safety

1. Members are responsible for their safety and that of their guests. Recklessness, taking of needless risks and other activities that create unsafe conditions are prohibited.
2. Club equipment undergoes extensive use under extreme sailing conditions. Members sail and use Club equipment at their own risk and should inspect all equipment carefully before use.
3. Sailing and windsurfing may be restricted or prohibited in high winds, fog, or other unsafe conditions.
4. Novice, Junior, and J+ rated members may not use club boats or boards if there is no Dayleader or there is no operable rescue skiff.
5. Secondary flotation (PFD, or long-sleeve, long-leg wetsuit and windsurf harness) must be worn when sailing, windsurfing, kayaking, or using an SUP. A windsurfer rated Junior or above may use a long-leg wetsuit and windsurf harness without a PFD while windsurfing.

A.2. City, State, Federal Regulations

1. Members are responsible to know and obey City, state, and federal regulations, especially Berkeley Marina and US Coast Guard regulations.

A.3 Conduct Policy

1. Sexual harassment is defined as any unwelcome sexual advance or conduct that creates an intimidating, hostile, or offensive environment. Any conduct of a sexual nature that makes a member or employee uncomfortable has the potential to be sexual harassment. CSC will not tolerate sexual harassment and will discipline any wrongdoers. The procedure for filing sexual harassment complaints is by contacting the Conduct Chair at <mailto:conduct@cal-sailing.org> or by filing an incident report form. CSC will investigate fully any complaint received and will not tolerate retaliation against anyone who complains about sexual harassment.

A.4 Enforcement and Cooperation

1. The Dayleader on duty (the member with Dayleader rating who has signed in at the clubhouse) will generally supervise club operation and enforce club rules. [Penalties and procedures: see CSC Bylaws Article X]. Exception: Senior and Cruising members outside clubhouse and Junior Area.
2. When directed by the Dayleader, club members shall assist in any task needed for the operation of the club.

A.5 Membership Dues and Ratings

1. As of January 2025 Dues are \$150 (or 10 hours of work) for 3 months, \$119 (or 10 hours of work) for 3 months for students and seniors, \$90 (or 10 hours of work) for minors (under 18 years old). Annual memberships are \$450 (of 30 hours of work). Combined dues for all the members of a family (related as parents/guardians/children) who purchase memberships at the same time in the clubhouse is \$215 (or 15 hours of work) for 3 months. Minor (under 18) memberships require approval by Excom, medical form and liability waiver must be kept on file in the clubhouse, and dues can be discounted to \$1 for 3 months if the minor member agrees to show up on four Saturday mornings to help teach lessons. Work in exchange for membership can consist of teaching in the scheduled sailing or windsurfing lessons, giving a club cruise (Cruising Skippers only), working full shift as day leader (rated day leaders only), or other work approved by a day leader of Excom member.
2. Annual dues for windsurf locker associate memberships are \$500 for regular size windsurf locker, \$750 for 1.5 size locker, payable by May 1 each year, with a 30 day grace period, after which a \$35 late fee is due.
3. Ratings expire after five years lapse in membership. Ratings can be reinstated after an evaluation by a Senior member for the rating category (Dinghy, Keelboat, Windsurf).

A.6 Use of Club Equipment

1. Use of club equipment by Novice, Junior, and J+ members may be restricted or prohibited by the Dayleader.

2. Sailboats, windsurf boards/rigs, kayaks, and standup paddleboards:
 - may only be used by appropriately rated members, and
 - must be signed in and out at the clubhouse, except that keelboats must be signed out at J dock.
3. Members are responsible for checking club equipment before and after use. Club equipment must be properly put away after use, Dayleader will judge proper stowage.
4. Windsurfing sails may not be left unattended on the dock or by the hoist.
5. All dinghies must have masthead flotation.
6. Dinghy sails shall be lowered or furled at the dock to prevent luffing damage, and secured so they remain in the boat.

A.7 Damage and Repairs

1. Any damage found on club equipment, and any repairs done, must be recorded, the Dinghy Log on the Club website or the Keelboat Log on the Club Website.
2. If damage cannot be repaired by the member who caused it, that member is responsible for contacting the appropriate Vice Commodore and arranging to do equivalent club work appropriate for the damage.
 - dinghies and rescue skiffs—1st Vice Commodore
 - windsurfers—2nd Vice Commodore
 - keelboats—3rd Vice Commodore

A.8 Lessons and Club Activities

1. Members may sign up for scheduled lessons
 - Dinghies:
Monday and Thursday, 1-4pm (1-5 pm during Daylight Savings Time)
Saturday, 10am – 1pm
 - Beginning Windsurf: (weather permitting): Saturday 10:30am – 2pm and Sunday 11am-2pm as scheduled during late Spring, Summer, and early Fall
 - Keelboat; (requires Jr Skipper rating) Wednesday 6–10pm
2. Tides, wind, and other factors may require cancellation or rescheduling
3. Scheduled lessons take precedence over all other activities.
4. Club activities are scheduled by the Executive Committee and by the officers responsible for activities.
5. Club activities take precedence over individual members' recreational sailing and windsurfing.

A.9 Work Requirement

1. Members are required to regularly contribute to the Club through a work requirement. The work requirement (also known as work hours or volunteer hours) can be completed through activities such as teaching, repairing, cleaning, assisting with Open Houses or

other Club activities, volunteer dayleading (requires rating), testing (requires rating), or completing clerical, administrative, or other tasks designated by Dayleader or Excom.

2. Minimum: 2 hours every 3 months, recorded by member on the member's account on the Club website. Not included: work towards free membership, repair of own damage, and Senior Projects. Members with Senior and Cruising ratings are required to contribute additional work.

A.10 *Kayaks and Standup Paddleboards*


1. Kayaks and standup paddleboards may be used only with the permission of the Dayleader, in the Junior Area. No rating is required. Equipment should be signed out on the Windsurf Sign-Out log.

A.11 *Reassessing Member Privileges*

1. Members are expected to operate equipment in a safe manner using sound judgement according to the conditions (e.g. wind strength and direction, water level, etc.)
2. The Day Leader or an Excom member may suspend a member's privilege to use equipment if in the Day Leader's judgement, that member has consistently failed to meet the requirements of A.11.1. This will then be escalated to Excom to investigate and determine the action path of either disciplinary hearing or skill reassessment.
3. A disciplinary action will follow the procedures of the Club By-Laws section X.
4. When an action described in A.11.2 is taken and Excom determines it is a skill-reassessment incident, a group of qualified members will be appointed to investigate and will recommend any necessary remedial action. This action may include suspension/revocation of rating and rating requalification, restrictions on the member's use of equipment, and other restrictions. It will also include what the member needs to demonstrate to regain a rating or remove restrictions

B. Novice and Junior Sailing/Windsurfing Areas

B.1. Novice Area



100 yards from any downwind shore

(note: usually the shores in the Novice area aren't downwind, they're upwind or sidewind, because the wind is from the west, but in south or east wind there can be downwind shores),

North of Hs Lordships restaurant, and

West of 3rd dock

B.2. Junior Area



Within sight of clubhouse, 100 yards from any downwind shore except to dock, north of Ashby Ave, and east of a line from the Emeryville Peninsula to Hs Lordships restaurant. The southern boundary can be determined by a range of the Ashby Ave. radio tower and the cupola of the Claremont Hotel.

C. Novice Windsurfer

1. Required Tests: Novice Windsurfer Written, Self-rescue (paddle upwind 100 yards), Sail Handling (carry sail properly)
2. Work Requirement: None beyond minimum
3. Who gives tests: Written Test online; self-rescue and equipment handling by Day Leader, J, J+, or Sr windsurfer
4. Restrictions: Novice Area only, wind less than 10 knots
5. Equipment: Boards with code N; Novice sails, except with the approval of the Day Leader, an instructor, or Excom member.

D. Junior Windsurfer

1. Required Tests:
 - Junior Windsurfer Written
 - Equipment Inspection
 - Basic Rigging (choosing and putting on a boom, assembling and carrying gear properly)
 - Sailing (on a 160L board without a centerboard and a sail ~1m² too big for conditions, sail into ways in 10-16 knots, tack up to the restaurant, gybe back down, and return to the dock. Tacks/gybes do not need to be consistently successful, but the ability to uphaul in the waves, get upwind, and come back down to the dock is required).
2. Work Requirement: one-time work requirement of 2 hours
3. Who gives tests: Senior Windsurfer for Sailing tests, J+/Senior for basic rigging, online for the Written Test.
4. Restrictions: Junior Area
5. Equipment: Boards marked N or J, any sail

E. Junior + Windsurfer

1. Required Tests:
 - Written Test
 - Complete sail rigging (from the bag: choosing a mast and boom, rigging outhaul and downhaul correctly)
 - Board Repair (fix, with assistance, if necessary, one board with fiberglass damage)
 - Sailing (On a 135L board or less, waterstart consistently on both tacks, controlled planing upwind both tacks in harness, with footstraps)
2. Work Requirement: one-time work requirement of 2 hours

3. Administered by: Rigging, Board Repair, and Sailing Test given by Senior Windsurfer; Written Test online.
4. Restrictions: Junior Area
5. Equipment: Boards marked N, J, or J+ any sail
6. Junior Windsurfer Rating

F. Foiling Windsurfer

1. Required Tests: Written
2. Work Requirement: one-time work requirement of 2 hours
3. Administered online
4. Restrictions: 4 ft. minimum water depth when the tide is falling; 3 ft minimum water depth when the tide is rising, as measured at the end of the dock. J+ or Sr area (depending on rating), with a good buffer (> 50 ft.) away from land.
5. Equipment: Boards marked with F, any sail
6. J+ or Sr rating

G. Novice Skipper

1. Required Tests: Junior Skipper Written, Rigging, Novice Sailing (dock, anchor, capsized recovery, tack, and jibe)
2. Work Requirement: None beyond minimum
3. Administered by: Senior Dinghy Skipper for Rigging and Novice Sailing test, online for written test
4. Restrictions: Novice Area only, winds less than 10 knots, single-hand or take one club member
5. Equipment: Trainer dinghies (RS Quests, RS Ventures, RS Touras); online test required to sail RS Ventures and RS Touras.

H. Junior Skipper

1. Required Tests: Junior Skipper Written, Rigging, Sailing (tack, jibe, small circles, man overboard drill, anchor, capsized recovery, and dock in wind >10 knots)
2. Work Requirement: one-time work requirement of 2 hours
3. Administered by: Senior Dinghy Skipper for Rigging and Sailing tests, online for written test
4. Restrictions: Junior Area, no use of bowsprits or gennaker on dinghies.

5. Equipment: Trainer dinghies (RS Quests, RS Ventures, RS Touras, JY-15s, Lasers, c420); special checkout by a qualified member is required to sail Lasers and c420. Online test required to sail RS Ventures, RS Touras, and JY15s.
6. Reefing may be required by the Day Leader, based on wind and sea conditions, and other relevant factors.
7. Safety Equipment: Except for the Laser, anchor and paddle must be on board.

I. Senior and Cruising Sailing/Windsurfing Areas

I.1. *Senior Areas*

This chart shows the Senior Dinghy and Windsurfing Area and the Senior Keelboat Area graphically. Text descriptions are in the following sections.



I.2. *Senior Dinghy and Windsurfing Area*

North of a line from the southwest corner of the Emeryville Peninsula to the north end of Treasure Island, east of a line from the east end of the Bay Bridge to X buoy, and south of a line from X buoy to the northwest tip of Cesar Chavez Park

If the X buoy is not in service, the X buoy location is assumed to be the GPS coordinates 37°52.34' N 122°21.51' W. Ranges can be used to get a good approximation to this location: the intersection of the following ranges:

1. from the north end of Cesar Chavez Park to the north end of Angel Island and

2. from the east end of Brooks Island to the visible west end of Treasure Island.

Note that the X buoy location is on the range through the #3 channel mark near the Berkeley Pier to the east end of the Bay Bridge. These ranges are shown in the chart in [section I.1.](#)

I.3. *Senior Keelboat Area*

North of a line from the southwest corner of the Emeryville Peninsula to the north end of Treasure Island, east of a line from the Bay Bridge tower east of Treasure Island to the end of the Richmond Jetty, ¼ mile south of all of the Richmond Jetty and Brooks Island, and south of a line from a point ¼ mile south of the southernmost point on Brooks Island to Fleming Point.

I.4. *Cruising Dinghy Area*



North of a line from the southwest corner of the Emeryville Peninsula to Clipper Cove, all of Clipper Cove, east of a line from the end of the jetty on the southeast corner of Treasure Island to the west end of the Richmond Jetty with room to round the end of the jetty, and east of a line from the west end of the Richmond Jetty to the end of the jetty at the southwest corner of Pt Richmond.

I.5. *Cruising Keelboat Area*

1. The inland and tributary waters of the San Francisco Bay and outside of the Golden Gate no further west than a straight line drawn from Point Bonita Light through Mile Rocks Light to the San Francisco shore.

J. Senior Windsurfer

J.1. Senior Windsurfer Rating

1. Required Tests: J+ windsurfer; approval by Excom based on judgment, sailing ability, and contribution to club; written, Sr Windsurfing
2. Work Requirement: Senior Project approved by Excom
3. Administered by: Windsurf Rating Chair (written test) Rating Committee members authorized to give Sr Windsurfing test
4. Equipment: boards marked J, J+, or S.
5. Area: Senior Area
6. Restriction: daylight hours only

J.2. Senior Windsurfer Responsibilities

1. At least 10 hours teaching, repair, cleanup, volunteer dayleading, Jr tests, or administration every 3 months, signed off on member's account on the Club website.

K. Senior Dinghy Skipper

K.1. Senior Dinghy Skipper Rating

1. Required Tests: Jr Skipper, Approval by Excom based on judgment, sailing ability, and contribution to club; Senior Dinghy Written test, two Dinghy tests on different dinghies (heavy weather, usual and unusual maneuvers)
2. Work requirement to get rating: Senior Project approved by Excom. This project can be applied to the Senior Skipper rating also, without the need for a second project.
3. Administered by: Sailing Examiner Chair (written test), two separate Rating Committee members authorized to give dinghy tests
4. Equipment: All Club dinghies. Equipment Required on Dinghies for Cruising (see below at [N.6.2](#)) when sailing outside the Junior Area. The First Vice Commodores may require special sign-off for specific dinghies.
5. Area: Senior Area
6. Restrictions: Single-handing any Club dinghy during the hours of darkness outside the Novice Area requires the presence of another CSC boat.

K.2. Senior Dinghy Skipper Responsibilities

1. At least 10 hours of teaching, repair, cleanup, volunteer dayleading, Junior tests, and/or administration every 3 months, signed off on the member's account on the Club website.

K.3. *Equipment Required*

1. When sailing outside Junior Area must carry [Equipment Required on Dinghies for Cruising \(N.6.2\)](#)

L. Senior Keelboat Skipper**L.1. *Senior Keelboat Skipper Rating***

1. This rating is a Senior rating for keelboats only.
2. Required Tests: Jr Skipper, Approval by Excom based on judgment, sailing ability, and contribution to club; Senior Keelboat Written test, Keelboat Sailing (heavy weather, usual and unusual maneuvers). Two keelboat tests with different testers in different boat types, and neither boat type should require an additional signoff beyond Senior.
3. Work Requirement: Senior Project approved by Excom. This project can be applied to the Senior Skipper rating also, without the need for a second project.
4. Administered by: Sailing Examiner Chair (written test), two separate Rating Committee members authorized to give keelboat tests.
5. Equipment: All club keelboats. The Third Vice Commodores may require special sign-off for specific keelboats.
6. Restrictions: Keelboats may not be single-handed without Excom approval.
7. Area: [Senior Keelboat Area](#)

L.2. *Senior Keelboat Skipper Responsibilities*

1. At least 10 hours of teaching, repair, cleanup, volunteer dayleading, Junior tests, and/or administration every 3 months, signed off on the member's account on the Club website

L.3. *Required Equipment*

1. All Coast Guard Required Safety equipment
2. At least one working, waterproof VHF radio and/or cell phone
3. Anchor and rode, paddles
4. Working compass
5. First Aid kit, knife, screwdriver, wrench, and pliers
6. Non-overlapping jib (storm jib) and bailing bucket

M. Senior Skipper

M.1. *Senior Skipper Rating*

1. This rating is a Senior rating for keelboats and dinghies. A Senior Skipper has all the rights and privileges of a Senior Dinghy Skipper and a Senior Keelboat Skipper.
2. Required Tests: Jr Skipper, Approval by Excom based on judgment, sailing ability, and contribution to club; Dinghy & Keelboat Written tests, Dinghy and Keelboat Sailing (heavy weather, usual and unusual maneuvers). One dinghy test and one keelboat test. For a member with a Senior Dinghy rating, only one test (keelboat) is necessary. For a member with a Senior Keelboat Rating, only one test (dinghy) is necessary.
3. Work Requirement: Senior Project approved by Excom. A completed project for a Senior Dinghy Skipper or a Senior Keelboat Skipper rating is sufficient.
4. Equipment: All club boats, including dinghies with gennaker. The First Vice Commodores may require special sign-off for specific dinghies. The Third Vice Commodores may require special sign-off for specific keelboats.
5. Restrictions: Keelboats may not be single-handed without Excom approval. Single-handing any Club dinghy during the hours of darkness outside the Novice Area requires the presence of another CSC boat.
6. Area: Keelboats—Senior Keelboat Area; Dinghies—Senior Area

M.2. *Senior Skipper Responsibilities*

1. At least 10 hours of teaching, repair, cleanup, volunteer dayleading, Junior tests, and/or administration every 3 months, signed off on the member's account on the Club website.

M.3. *Equipment Required*

1. Keelboats:
 - a. All Coast Guard Required Safety equipment
 - b. At least one working, waterproof VHF radio and/or cell phone
 - c. Anchor and rode, paddles
 - d. Working compass
 - e. First Aid kit, knife, screwdriver, wrench, and pliers
 - f. Non-overlapping jib (storm jib) and bailing bucket
2. Dinghies: when sailing outside Junior Area must carry [Equipment Required on Dinghies for Cruising \(N.6.2\)](#)

N. Cruising Skipper

N.1. *Cruising Dinghy Skipper Rating*

1. Required Tests: Senior Dinghy Rating, Cruising written test, First Aid Course, 3 dinghy qualifying cruises, approval by Excom based on reports from Skippers who administered the qualifying cruises. Each qualifying cruise must be supervised by a different cruise skipper.
2. Administered by: Sailing Examiner Chair (written test), Cruising Skipper (cruises)
3. Equipment: All dinghies. The First Vice Commodores may require special sign-off for specific dinghies.
4. Area: Cruising Dinghy Area
5. Qualifying Cruises:
 - a. Candidate must administer at least 3 Lottery Signup Cruises with 3 or more participating boats.
 - b. Candidate must skipper a separate boat from the Cruising Skipper administering test, but must remain within sight and must stay in radio or cell phone contact
 - c. At least 2 different destinations among the following areas:
 - (i) Clipper Cove
 - (ii) A destination north of Cesar Chavez Park
 - (iii) Coordinate an around the pier race
6. Restrictions:
 - a. Single handing outside the Senior Dinghy and Windsurfing Area is permitted only in the company of another CSC boat.
 - b. A dinghy skippered by a Senior may enter the Cruising Dinghy Area only with the approval of an accompanying Cruising Skipper.
 - c. All participating dinghies must stay in visual contact during a cruise.

N.2. *Cruising Keelboat Skipper Rating*

1. Required Tests: Senior Keelboat Rating, Cruising written test, Standard First Aid Course, 3 keelboat qualifying cruises, approval by Excom based on reports from skippers who administered the qualifying cruises. Each qualifying cruise must be supervised by a different cruise skipper.
2. Administered by: Sailing Examiner Chair (written test), Cruising Skipper (cruises)
3. Equipment: All club keelboats.
4. Qualifying Cruises
 - a. Candidate must administer at least 3 Lottery Signup Cruises.
 - b. Candidate can skipper separate boat with approval by Cruising Skipper administering test, but must remain within sight and must stay in radio or cell phone contact
 - c. At least 4 different destinations among the following areas:

- Raccoon Strait: must extend into Raccoon Strait
 - West Bay: Outside the Golden Gate Bridge
 - North Bay: must pass to some point North of Bluff Point
 - South bay: must pass under the Oakland Bay Bridge
- d. One of the cruises must have at least two boats, and the candidate must manage this.
 - e. One of the cruises must return after dark, meaning at least one half hour after official sunset.
5. Area: Cruising Keelboat Area, no cruises more than 24 hours without advance approval by Excom
 6. Private Cruises: Skipper entitled to one private cruise after a keelboat lottery cruise, or a dinghy cruise announced at least 10 days in advance.
 7. Restrictions: Keelboats may not be single-handed without Excom approval

N.3. Cruising Skipper Rating

1. This rating is a Cruising rating for keelboats and dinghies
2. Required Tests: Senior Skipper Rating, Cruising written test, Standard First Aid Course, 3 keelboat qualifying cruises and 1 dinghy qualifying cruise approval by Excom based on reports from skippers who administered the qualifying cruises. Each qualifying cruise must be supervised by a different cruise skipper.
3. All qualifying cruise requirements of the Cruising Keelboat Skipper Rating and one destination from the Cruising Dinghy Skipper Rating.

N.4. Cruising Skipper Responsibilities

1. All Senior Skipper responsibilities
2. Administer one Lottery Signup Cruise every year
3. Complete cruise form before and after cruise according to the procedure specified by the Third Vice Commodore.

N.5. Club Cruises

1. Keelboat Lottery Cruises
 - a. Skipper must post cruise notice on web site at least 10 days in advance of cruise; skipper must administer lottery.
 - b. A Senior may skipper another boat with the approval of the Cruising Skipper giving the cruise. The other boat must be in visual and radio contact with the Cruising Skipper at all times while outside the Senior area.
 - c. Club cruises take precedence over private cruises.
 - d. Skippers and each club member signing up may take one guest.
2. Dinghy Cruises

- a. Skipper must post cruise notice on web site at least 10 days in advance of cruise.
- b. Skipper determines required qualifications of individual boat skippers and of members for the cruise. Selection of boat skippers and members is at the discretion of the Cruise Skipper.
- c. A Senior Dinghy skipper may skipper another boat with the approval of the Cruising Skipper giving the cruise. The other boat must be in visual and radio contact with the Cruising Skipper at all times while outside of the Senior area.

- d. Guests are not allowed on dinghy cruises.

N.6. *Equipment Required for Cruises*

N.6.1. Keelboat

- a. All Coast Guard Required Safety equipment
- b. A working outboard motor and sufficient gas
- c. At least one working, waterproof VHF radio and/or cell phone
- d. Anchor and rode, paddles, working compass
- e. Two flashlights, at least one floating, first Aid kit, knife, screwdriver, wrench, and pliers
- f. Charts covering the area of the cruise
- g. Non-overlapping jib (storm jib) and bailing bucket

N.6.2. Dinghy

- a. All Coast Guard Required Safety equipment
- b. At least one working, waterproof VHF radio and/or cell phone secured to PFD
- c. Anchor and rode, paddle
- d. Working compass
- e. Two flashlights, at least one floating
- f. First Aid kit, knife, screwdriver, wrench, and pliers

O. Dayleader

O.1. *Dayleader Rating*

1. Required Training and Tests: as specified by Port Captain
2. Administered by: Port Captain
3. Equipment: Rescue Skiffs

O.2. Dayleader Responsibilities

1. Dayleader is responsible for performing the following duties or delegating them to a responsible club member:
 - a. Opening and closing the club
 - b. Signing in when on duty, both in logbook and on chalk board by clubhouse door
 - c. Launching and operating rescue skiff
 - d. Performing rescues, including obtaining and using club members to assist in rescues in >15 knots or rescues of sailors/windsurfers on or near rocks
 - e. Watching for sailors and windsurfers in distress on the water, especially in high wind
 - f. Selling memberships and answering questions at the desk
 - g. Administering written tests for Novices and Juniors, and Self-rescue test for Novice Windsurfers
 - h. Directing club members to fulfill work requirements, signing off volunteer hours on the Club website.
 - i. Supervising operations in the clubhouse, dock, and yard including lessons, club activities, work, and recreational sailing and windsurfing
 - j. Enforcing rules, and permitting sailing and windsurfing by N, Jr, and J+ rated members only when safe
 - k. Monitoring the VHF radio in the clubhouse, and responding to calls to Cal Sailing Club on Channel 16 and 69 or other specified channels
2. Important: The dayleader may direct any club member to assist in these responsibilities as needed. Dayleaders are required to get help on rescues in high wind or near rocks.

O.3. Rescue Skiffs

1. Only members trained and certified by the Port Captain may operate the rescue skiffs
2. A CA Boater Card is required to operate the rescue skiff
3. The rescue skiffs are only to be operated for rescues, lessons, training, and other Club activities approved by Excom. No unnecessary speed, wave jumping, etc.
4. Kill switch lanyard must be worn when driving; remove only for docking, picking up people, etc.
5. Before launching, skiff must be checked and readied for rescues, including gas, oil, anchor, tow line, extra line, drain plugs, and submersible VHF radio.
6. Area: Junior Area, unless skiff is needed outside Junior Area for rescues or club activities

O.4. Restriction/Prohibition of Sailing and Windsurfing

1. Dayleader should generally allow N, Jr, or J+ rated members to sail or windsurf if the following conditions are met:
 - a. rescue skiff ready to perform rescues
 - b. wind <10 knots for N, <20 knots for Jr, <25 knots for J+. Use discretion for individual members as prescribed in (d).
 - c. the member has properly selected and rigged the equipment
 - d. the member's sailing ability and physical condition is adequate for the conditions

- e. the member is up to date on work requirement and other responsibilities
